


AIS in Mobile

- The Income Tax Department has launched a app "AIS for Tax Payer" to make it easier for taxpayer to access their information as made available in the "Annual Information Statement" (AIS) or "Taxpayer Information Summary" (TIS) at the Income Tax Portal.
- This app can be downloaded from Google Play as well as the Apple App Store.
- The app will enable you to verify the information which is reported against your PAN as and when updated at Income Tax Portal pertaining to TDS / TCS, Interest Income, Dividend Income, transactions in shares & Mutual Funds, Investments in FD / RD, Tax payments, Income Tax refunds and other information such as Data as per GST, Foreign remittances, etc.
- You can easily verify the details from the app and also provide feedback for the transactions reported such as "Information is correct", "Information is incorrect", "Information relates to other PAN", etc.

Steps to Download & Register


- Go to the Google Play Store or App store and download the app "AIS for Tax Payer".
- Register yourself using your PAN and Date of Birth / Incorporation / Formation.
- Then enter the primary Email ID & Mobile number registered at the Income Tax Portal and authenticate using OTP sent separately on Email & Mobile.
- Once this authentication is complete, you are required to complete the registeration by updating a 4-digit PIN which will be required to use the mobile app.
- Once the setup is complete, you can then access the app using the MPIN set by you.





How to access data

- Login to the app using your MPIN.
- Click on the tab named "Annual Information System"
- Click on AIS or TIS as per your requirement.
- Select the Financial Year for which you wish to view the data.
- The information will then be displayed on your screen.
- You can then click on each transaction, view them and also provide feedback
- The options available are:
 - Information is correct
 - Income is not taxable
 - Information is not fully correct
 - Information relates to other PAN / Year
 - Information is duplicate / included in other information
 - Information is denied
- Further information can be provided after selecting the relevant option.
- This will now enable you to verify and update your information at anytime and from anywhere.
